I realize and accept the fact that athletic participation involves strenuous physical movement, effort and body contact, which contains an element of potential "risk" of personal injury to my child. I further realize that the school district assumes no liability for student injury expense that might be the result of athletic practices or games. I am aware of the limited-benefit accident insurance policy purchased by the school district which may assist in payment of some injury expense. I also realize that, in the event of injury, I must file a claim with all other available sources of insurance coverage before attempting to collect benefits under the school district plan, since it will not pay for hospital or doctor bills that are collectible under other group insurance or service contracts. I further understand that, in the event of injury, treatment must begin within 30 days after the date of injury, and it is my responsibility to report the accident to school personnel and request the necessary claim form from them. (A detailed description of the school district plan is attached.) I will accept responsibility to pay any medical expense not covered by my own insurance policy or that provided by the school district.

I understand that the accident plan purchased by the school district does not cover my child at any time other than during interscholastic practices and games. It will be my responsibility to purchase the regular student plan offered, in order to obtain coverage during school time or on a 24-hour basis. (This is not required, but highly recommended.)
